WATER WORKS AND SEWER BOARD OF THE CITY OF SELMA RATE STRUCTURE

RESIDENTIAL RATES:

Water rates inside of the city limits: See Speed Chart- R (made available upon request) The minimum usage of 3,750 gallons equivalent to 4 cubic feet of water. Sewage is 100% of the water cost.

Water rates outside of the city limits: See Speed Chart- A (made available upon request) The minimum usage of 3,750 gallons equivalent to 4 cubic feet of water. Sewage is 100% of the water cost.

Commercial Rates:

Water rate with 3/4 to 1" meter See Speed Chart (made available upon request) The minimum usage of 3,750 gallons equivalent to 4 cubic feet of water. Sewage is 100% of the water cost.

Water rate with 1 1/2" meter See Chart (made available upon request) The minimum usage of 3,750 gallons equivalent to 4 cubic feet of water. Sewage is 100% of the water cost.

Water rate with 2" meter See Speed Chart (made available upon request) The minimum usage of 3,750 gallons equivalent to 4 cubic feet of water. Sewage is 100% of the water cost.

Water rate with 3 meter See Speed Chart (made available upon request) The minimum usage of 3,750 gallons equivalent to 4 cubic feet of water. Sewage is 100% of the water cost.

Water rate with 4" meter See Speed Chart (made available upon request) The minimum usage of 3,750 gallons equivalent to 4 cubic feet of water. Sewage is 100% of the water cost.

Water rate with 6" meter See Speed Chart (made available upon request) The minimum usage of 3,750 gallons equivalent to 4 cubic feet of water. Sewage is 100% of the water cost.

Water rate with 8" meter See Speed Chart (made available upon request) The minimum usage of 3,750 gallons equivalent to 4 cubic feet of water. Sewage is 100% of the water cost.

Water Works and Sewer Board of the City of Selma Billing and Statements:

There will be an increase in the bills of 2.5% throughout the life of the 2006 construction bond (30 years), the increase will be effective every year in the month of June.

Billing is done in three (3) zone and they are listed below:

Zone # 1: All customers west of Broad Street, bounded by the Alabama River to J. L. Chestnut, to Valley Creek and south of the Southern Railway tracks. Billing date the 10th of each month.

Zone # 2: All customers north of J. L. Chestnut Blvd. and west of Board Street, to Woodrow Avenue. Billing date the 20th of each month.

Zone # 3 All Customers east of Board Street from the Alabama River to the northern city limit and extend to the east of the city limits. Billing the 30th of each month.

The Board reserves the right to make or amend the Rules and Regulations, rates and fees of the Board from time to time and the Water User agrees to abide by such changes upon notice thereof.
